Participation in voting for Board members is described in 7a. Also see response to 7b. Membership does not include participation in the assets of the organization upon dissolution.

Form 990, Part VI, Section A, Line 7a - 4 of the 10 Board members are elected by the 28 Wycliffe Member Organizations who have been granted the right to vote (out of 106 Organizations that make up the Alliance). Of the remaining six Board seats, 1 is slotted for the CEO of our founding organization and 5 are from the constituency, one each from different geographical areas of the world. These are chosen by an Area level process approved by the Board.

Form 990, Part VI, Section A, Line 7b - All By-Laws changes require ratification by the 28 member organizations with vote.

Form 990, Part VI, Section B, Line 11b - Before filing, the Form 990 is reviewed by the Audit Committee, Board Committee on Finance and full Board for inquiry.

Form 990, Part VI, Section B, Line 12c - The Conflict of Interest Policy requires Board members, Officers and Key Employees to sign a statement stating that they have no conflicts of interest (or disclosing them if they do). Due to the nature of the Board members (chosen for their expertise in the field, not for business or supporter contacts) no conflict of interest has ever arisen. If it were to arise, the individual would be required to excuse himself from decisions related to the event, and the Board Committee on Finance would monitor the transactions.

These proposals are prepared by managers within the normal course of their duties of managing programs and does not represent any significant amount of time overall for them. Because most of this work is done by donated labor, there is not any labor cost to apportion to it on the 990, and any office cost would be minimal.

Form 990, Part IX, Line 11g - Fees for other services includes: \$441,949 in consultant fees related to operating Bible translation programs and \$67,917 for outsourced professional services for office support.
