

# **Participation Streams in the Wycliffe Global Alliance**

(12 April 2019 revision)

## **Introduction**

The Participation Streams (Streams) of the Wycliffe Global Alliance (the Alliance) are presented here in recognition of the diversity and the many ways in which God has provided for and gifted Alliance Organizations in their contexts and cultures, and in their abilities to serve both regionally and globally. This document provides an overview of Streams the Alliance has recognized as important, so that Alliance Organizations can have clarity of purpose and activity in their participation.

## **Overview of the Streams**

The Alliance recognizes that the following Streams are the primary means by which Alliance Organizations play a part in Bible translation movements that contribute to the holistic transformation of language communities worldwide.

Each Stream lists accompanying markers that show how an Alliance Organization may be involved. These markers help Alliance leaders and Alliance Area Directors understand and gauge how an Alliance Organization is participating. Alliance Organizations are encouraged to share within the Alliance community their experiences and lessons learned through their involvement in any of the Streams.

## **Assumptions about the Streams**

- Each Alliance Organization's involvement in a Stream includes contributing beyond support of its own personnel (in prayer, funding, etc.). While an Alliance Organization may fulfill these 'internal' functions on behalf of their personnel, they also value and participate in a wider, networked context that supports global Bible translation movements.
- An Alliance Organization may have a particular audience focus. This audience focus may be regional, cultural, based on demographics, etc. But, whoever the audience is, Alliance Organizations are encouraged to participate with others in the Alliance and with partners as a demonstration of the unity of the body of Christ.
- Alliance Organizations are encouraged to discern which ways God has called and equipped them to contribute. There is no emphasis to be involved in as many Streams as possible. The Alliance Area Director, in relation to those Alliance Organizations in their respective Area, maintains a database of information on each Stream that those Alliance Organizations are participating in, and is able to obtain regular updates from them.

## **The Participation Streams**

All of the Streams are considered to be important. Therefore, they are not presented in any order of priority. The markers of involvement noted are not meant to be comprehensive, and by listing them there is no expectation of full involvement in each of them. The marker statements are examples.

<b>CHURCH</b>	<p>An Alliance Organization relates to local churches and church organizations for the purpose of participating together in the mission of God. These relationships include a focus on Bible translation and/or related ministries with minority language communities. It is recognized that some Alliance Organizations are churches or church denominations.</p> <p>Alliance Organizations demonstrably come alongside churches to encourage, help strengthen, and help equip them to fulfil a meaningful role in Bible translation.</p> <p>Involvement with a church or church organization may, for example, be done through:</p> <ul style="list-style-type: none"> <li>● missional awareness</li> <li>● networking/partnering</li> <li>● vision sharing and advocacy</li> <li>● encouraging involvement in Bible translation movements and related ministries</li> </ul> <p>The relationships of the Alliance Organizations with a church or church organization are inspired by the Statements on the <a href="#">Church</a>.</p>
<b>Evidenced by:</b>	<ul style="list-style-type: none"> <li>● An Alliance Organization demonstrates an intentional focus on relationships with churches and/or church organizations.</li> <li>● An Alliance Organization has staff<sup>1</sup> involved in building and expanding relationships with local churches and church organizations.</li> <li>● An Alliance Organization can demonstrate how churches they relate to participate in Bible translation.</li> </ul>

<b>PRAYER</b>	<p>Even though it is acknowledged that prayer plays an important part in the life of every Alliance Organization, in the Prayer Stream, we want to recognize the part that an Alliance Organization plays in encouraging and supporting prayer by means of, e.g.,:</p> <ul style="list-style-type: none"> <li>● developing and/or overseeing prayer programs and initiatives (often in cooperation with other organizations and networks).</li> <li>● participating as advocates in prayer movements and events.</li> <li>● coordinating, sharing and distributing prayer information to stimulate and sustain regional and global prayer groups and networks in prayer for Bible translation movements.</li> </ul>
<b>Evidenced by:</b>	<ul style="list-style-type: none"> <li>● An Alliance Organization demonstrates an intentional focus on prayer advocacy and development of prayer support.</li> <li>● An Alliance Organization has staff involved in coordinating prayer</li> </ul>

	<p>and prayer information, vision sharing and other related activities. (This prayer focus extends beyond the prayer needs of their own personnel.)</p> <ul style="list-style-type: none"> <li>● An Alliance Organization uses communication networks to share stories of how God is working through prayer movements and the prayers of His people.</li> </ul>

<b>FUNDING</b>	<p>An Alliance Organization encourages generosity for Bible translation by raising funds in the country where it is located, for the operations and/or support of Bible translation programs. Initiatives and activities that result in income generation are recognized as funding. An Alliance Organization helps donors/contributors/philanthropists understand the importance of the Alliance Principles of Funding. An Alliance Organization distributes its financial resources in a way that values and demonstrates an appreciation for national, regional and global efforts within the Alliance community.</p> <p>Funding practices among Alliance Organizations are inspired by the Alliance’s Principles for <a href="#">Funding</a>.</p>

<b>Evidenced by:</b>	<ul style="list-style-type: none"> <li>● An Alliance Organization demonstrates an intentional focus on building capacity in funding and/or conducting fundraising activities.</li> <li>● An Alliance Organization has staff involved in fundraising and the funds raised are for use beyond the needs of their own staff and their organization’s operating budget.</li> <li>● An Alliance Organization demonstrates measurable fundraising activities.</li> <li>● An Alliance Organization uses communication networks to share stories of how God is generously providing.</li> <li>● An Alliance Organizations leads or develops biblically-based generosity training in churches or ministries giving generously for the work of Bible translation.</li> </ul>

<b>PEOPLE</b>	<p>An Alliance Organization recruits and/or sends people to serve in Bible translation movements either in their country of origin or elsewhere in the world. These people may serve in their own organization, another Alliance Organization, or other partners of the Alliance. This function also includes ongoing supportive care.</p> <p>People practices among Alliance Organizations are inspired by the Alliance’s Statement on <a href="#">People</a>.</p>

<b>Evidenced by:</b>	<ul style="list-style-type: none"> <li>● An Alliance Organization demonstrates a measurable and intentional focus on seeing people engaging and serving in Bible</li> </ul>

<b>BIBLE TRANSLATION PROGRAMS</b>	An Alliance Organization manages one or more Bible translation programs, which will typically include Scripture engagement and literacy. The Alliance <a href="#">Translation</a> Programs Philosophy inspires and guides Alliance Organizations in these programs.

<b>Evidenced by:</b>	<ul style="list-style-type: none"> <li>● An Alliance Organization demonstrates it has an intentional focus of managing a Bible translation program(s).</li> <li>● An Alliance Organization has one or more full-time (or equivalent) staff involved in the management of a Bible translation program(s).</li> <li>● An Alliance Organization has one or more full-time (or equivalent) staff involved in directly assisting a Bible translation program(s) and if it is in another country, this is done in cooperation with the Alliance Organization(s) or other partner(s) of that country.</li> <li>● An Alliance Organization has the capacity to maintain an adequate database on translation needs in their country.</li> </ul>

<b>TRAINING IN BIBLE TRANSLATION ROLES</b>	An Alliance organization regularly offers courses in topics relevant to Bible translation programs. These courses are often in cooperation with other organizations.

<b>Evidenced by:</b>	<ul style="list-style-type: none"> <li>● An Alliance Organization demonstrates an intentional focus on training in Bible translation roles.</li> <li>● An Alliance Organization has one or more full time (or equivalent) staff involved in the offering of training for Bible translation roles.</li> <li>● An Alliance Organization regularly offers training courses in topics relevant to Bible translation programs.</li> </ul>

<b>SPECIALTY SERVICES</b>	An Alliance Organization provides practical help and/or specialized consultation services, often for specified periods of time. This can include, for example, services in the areas of finance, technology, administration, organizational development, partnerships and human resources, etc. These services are provided based on the needs expressed by stakeholders and partners in Bible translation movements in minority language communities. The relevant Area Director is made aware of these services so that other Alliance Organizations may be informed and benefit from them.
